

Welcome Bonus Terms & Conditions

BAXIA GLOBAL LIMITED

Risk Warning: Margin trading involves a high level of risk, and may not be suitable for all investors. You must assess and consider them carefully before making any decision about using our products or services.



- 1. The Welcome Bonus campaign (referred to as the "Promotion") is conducted by Baxia Global Ltd ("Baxia Markets"), which is overseen by the Financial Services Authority (FSA) in Seychelles.
- 2. The Promotion is designed as an initiation, either for (i) potential clients from a selected region, interested in creating a live trading account with Baxia Markets, or (ii) existing customers who haven't yet performed a real money transaction with Baxia Markets ("You" or "Your").
- 3. By engaging in the Promotion, you express consent to adhere to these Welcome Bonus terms and Baxia Markets regular Client Agreement (including any addendums or changes), which are applicable to your account and always subject to any applicable laws (collectively referred to as the "Terms").
- 4. Baxia Markets acceptance policy may render certain countries ineligible for the Promotion (termed "Selected Regions").

To qualify for the Program, you must:

- 4.1. Reside in one of the Selected Regions;
- 4.2. Complete the profile verification with Baxia Markets including uploading Photo ID, Proof of Address, Payment Details and selfie verification;
- 4.3. Deposit at least the minimum required deposit;
- 4.4. Accept and adhere to the Welcome Bonus Terms.

These conditions are referred to as the "Requirements"

- 5. If you are an existing Baxia Markets customer, your are not eligible for the Promotion.
- 6. The Promotion allows for only one-time participation.
- 7. Expert Advisors (EAs) are not allowed on Welcome Bonus accounts.
- 8. The Welcome Bonus account has identical trading conditions to the live BX Standard account type.
- 9. The Client has the option to either raise or lower the leverage on the Welcome Bonus account.
- 10. The Welcome Bonus account is available in the USD currency.



- 11. Baxia Markets, at its sole discretion and assuming you meet the Requirements, pledges to immediately credit an amount of 30 USD into your Welcome Bonus account after you make the required deposit. This credit is termed as the "Welcome Bonus".
- 12. Baxia Markets maintains exclusive discretion in deciding whether to award you the Welcome Bonus. Additionally, Baxia Markets retains the right to deny or withdraw the Welcome Bonus without any liability if it finds your participation to be in violation of any Terms or if there are suspicions of multiple accounts owned by the same client or their immediate family. Baxia Markets reserves the right to reject a bonus request or block the Welcome Bonus account, if there is a partial or complete match of IP address or other signs of Welcome Bonus account belonging to the same person.
- 13. The Welcome Bonus is not withdrawable from your account.
- 14. It is not allowed to make third party deposits and Baxia Markets reserves the right to cancel bonus at any time upon detecting third party payment.
- 15. Baxia Markets reserves the right to remove any Welcome Bonus payments made by mistake.
- 16. If there is no trading activity in your live trading account for a period exceeding 90 days, Baxia Markets can decide to remove the Welcome Bonus completely.
- 17. All profits earned and transferred from the Welcome Bonus account are deemed to be null and void, if the Welcome Bonus account or live MT5 Baxia Markets account holder has provided incorrect, false or misleading information during the registration process.
- 18. Baxia Markets reserves the right to disqualify any user, if there is a suspicion of misuse or abuse of fair rules.
- 19. Hedging trading positions internally (using other trading accounts held with Baxia Markets) or externally (using other trading accounts held with other brokers) and thus avoiding market risk, is considered to be an abuse.
- 20. Using the failures in the quote flow for getting guaranteed profit or any other form of fraudulent activities are considered to be an abuse.
- 21. You agree to indemnify, defend and hold harmless Baxia Markets (including its directors, officers, employees and assigns) on written demand and at all times from and against any and all liability, fines, penalties, actions, judgement, settlement, claims, demands, losses, damages, injury, compensation, costs and expenses (including interest payments, reasonable legal fees on a solicitor/client basis, other professional fees and disbursements and costs of investigation and



litigation) for or in respect of which Baxia Markets will or may become liable by reason of or related or incidental to any act, default or omission and/or any breach of representation and warranty set forth herein by You under these Terms including without limitation resulting from or in relation to any breach, non- observance, act or omission whether negligent or otherwise.

- 22. To the extent permissible by law, You forfeit any rights to litigation, injunctive relief or any other form of judicial or non-judicial recourse in case of disputes or claims resulting from or related to this Promotion. You willingly renounce any and all such rights.
- 23. If the execution of the Welcome Bonus credit is hindered due to circumstances beyond Baxia Markets control, including but not limited to technical glitches or system failures, Baxia Markets will bear no responsibility towards you in relation to the Promotion.

Baxia Markets maintains the right to modify the terms of the Promotion or terminate it entirely whenever necessary.

Any disputes or likely misunderstandings that may occur as a result of the Campaign terms will be resolved by the Baxia Markets Management in a way that presents the fairest solution to all parties involved. Once such a decision has been made, it shall be regarded as final and/or binding for all parties.

Clients agree that information provided during the registration process may be used by the Company both within the context of the Welcome Bonus account Campaign and for any other marketing purposes.

These Terms shall be governed and construed in accordance with the laws of Seychelles. The parties irrevocably agree that the courts of Victoria, Mahe shall have the exclusive jurisdiction to settle any dispute arising out of or in connection with this Promotion.
